PREPAYMENT OPTIONS

Theatrical Motion Pictures

- 130% of the Performers' Net Fees for worldwide use in all media, excluding New Media for a period of 4 years from the date of first use in a residual market, or
- 135% of the Performers' Net Fees for worldwide use in all media, including New Media for a period of 4 years from the date of first use in a residual market

Free Television Series

- 105% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical and New Media, for a period of 5 years from the date of first exhibition in a residual market
- 110% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical, for a period of 5 years from the date of first exhibition in a residual market

Free Television Long-Form Programs

- 105% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical and New Media, for a period of 4 years from the date of first exhibition in a residual market
- 110% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical, for a period of 4 years from the date of first exhibition in a residual market

Cable Television

- 105% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical and New Media, for a period of 5 years from the date of first exhibition in a residual market
- 110% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical, for a period of 5 years from the date of first exhibition in a residual market

Pay Television, Compact Devices, Educational Programs

- 105% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical and New Media, for a period of 4 years from the date of first exhibition in a residual market
- 110% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical, for a period of 4 years from the date of first exhibition in a residual market

New Media

- 105% of the Performers' Net Fees for worldwide use in New Media only, for a period of 5 years from the date of first exhibition in a residual market
- 110% of the Performers' Net Fees for worldwide use in all media, excluding Theatrical, for a period of 5 years from the date of first exhibition in a residual market

ADVANCE OPTION

In lieu of a prepayment, the Producer may pay, at the time of production, one of the following percentages of Net Fees as a Non-Refundable Advance against the following Use Fees based on Performer Participation in Distributors' Gross Revenue:

Option Number	Non-Refundable Advance (% of Net Fees)	Participation in Distributors' Gross Revenue
1	100%	3.6%
2	75%	4.6%
3	50%	5.6%
4*	25%	6.6%

*Limitation of Selection of 25% Advance

The only circumstances which will allow a Producer to select option #4 is if there are only exclusively Canadian pre-sale(s) as of the first day of principal photography of the Production

INSURANCE AND RETIREMENT CONTRIBUTIONS

Insurance

6% of the Gross Fees (inclusive of Use Fees) paid to all Performers, to a maximum of \$3,000 per Performer per contract of engagement

Retirement

6% of the Gross Fees (inclusive of Use Fees) paid to all Members, to a maximum of \$6,000 per Performer per contract of engagement

Equalization Payments

6% of the Gross Fees (inclusive of Use Fees) paid to all non-Members, to a maximum of \$6,000 per Performer per contract of engagement

ADMINISTRATION FEES TO THE UNION

Producers that are members in good standing of the CMPA or an affiliate of the AMPTP

1% of Gross Fees paid to all Performers (including overtime and use fees) to the following maximums:

- \$1,500 per Production or Episode
- \$3,000 per Production (excluding Series) if the Gross Performers' Fees exceed \$2,000,000
- No administration fee for pilots and the first two seasons of a Series

Producers that are not members in good standing of the CMPA or an affiliate of the AMPTP

4% of Gross Fees paid to all Performers (including overtime and use fees) with no maximum, which shall be divided equally between UBCP/ACTRA and the CMPA-BC

Residuals Administration Fee

0.5% of Gross Fees paid to all Performers (including overtime and use fees) to the following maximums:

- \$250 per Episode of a Television Series to a maximum of \$1,500 per season
- \$1,500 for any other Production

ADMINISTRATION FEE TO THE CMPA-BC

Producers that are members in good standing of the CFTPA

1% of Gross Fees paid to all Performers (including overtime and use fees) to the following maximums:

- \$3,000 per Production or Episode
- \$5,000 per Production (excluding Series) if the Gross Performers' Fees exceed \$2,000,000
